Mobile responsiveness and accessibility

Our December system update included a complete overhaul of the site to optimise for mobile devices. Now, any pages you or your members access on a phone or tablet will resize automatically and present all elements in a mobile-friendly way.

The update also meets the latest requirements under the Web Content Accessibility Guidelines (WCAG) international standard. This includes larger text and icons, improved colour contrast, and improved compatibility with screen readers.

After you have completed a search, you will see the option to **Create as Resource**:

This will take you to a screen where you can select categories for the resource and edit its

summary (500 characters or fewer). Enter the categories appropriate to the search report and click publish. You have now published your search as a resource!

As best practice, we recommend that you take into consideration the following principles:

- Can the search stand on its own merit?
- Ensure that there is no identifying information about the requester or any other individual
- Edit the description to reflect that this is now an Evidence Search Resource

Following the recent vote on the Terminally III Adults (End of Life) Bill, much has been published on how this will be set out in law. What categories would you recommend?



The category **Death and Dying** represents the biological process of dying. Assisted Dying can be searched as an alias of this term, which is found within the Conditions and Lifestyle Factors field. Combining categories across the other fields will enable categorisers to capture associated legislative, ethical and psychological topics in assisted dying.

To capture resources relating specifically to legislation, combine **Death and Dying** with Advance Directives and Mental Capacity and Consent, which are found under **Professional Interests**, alongside appropriate Setting(s), Staff Group(s) and Age Group(s).
